**RE: COMPLAINT BY BRIAN YONGO**

Reference is made to your letter of 4<sup>th</sup> July 2012.

My understanding of the position of the Law Society is that the Affidavit sworn by Mr. Yongo dated 3<sup>rd</sup> May 2012, read together with his Further Affidavit sworn on the 21<sup>st</sup> May 2012 effectively withdrew the complaint against Mr. Ahmednasir Abdulahi. Notwithstanding your letter dated 11<sup>th</sup> June 2012, my response (made herein with respect and humility) is that there is no Affidavit I can respond to given the foregoing circumstances.

Nevertheless, I am constrained to comment on the issue of Mr. Ahmednasir Abdulahi (given the level of interest it has generated) as follows:


1. I recall that sometime in 1990 Mr. Ahmednasir, approached my Chambers, then situated on the 3<sup>rd</sup> Floor of Rehema House, Standard Street, with a request to attend Pupilage with my firm.
2. I accepted and he carried on his duties as a Pupil until he left for further studies to the USA. I do not recall the exact dates when he left.



3. As to whether Mr. Ahmednasir forged a certificated of Pupilage from my office, I cannot comment on this since I have **NOT** had site of the document complained of by Mr. Yongo to enable me respond to the same.
4. The events referred to herein took place over twenty years ago and my records for this period are unavailable. However, given that Mr. Ahmednasir did his Pupilage in my Chambers I believe that I may have signed a Certificate of Completion in the manner that Pupilage Masters normally do.
